STAY IN LODZ

If you like Lodz very much and you intend to stay here for a long time, you need to consider the issues of legalizing your stay, buying a flat, finding a job or starting your own business.

Legal basis - the Act on Foreigners of 12 December 2013.

You can apply for a temporary residence permit if there are circumstances justifying residence in the territory of the Republic of Poland for a period longer than 3 months. As a rule, a temporary residence permit is granted for a maximum period of up to 3 years.



how to submit the application

The application is submitted by a foreigner applying for a permit in person to the voivode competent for the foreigner's place of residence, no later than on the last day of legal stay in the territory of the Republic of Poland.

If the application is not submitted in person or is sent by post - after delivery of the application to the voivode, the foreigner will be summoned to appear in person within 7 days of the delivery of the summons under pain of leaving the application without examination.



place for submitting documents

Documents should be submitted to the seat of the Department of Citizens' Affairs and Foreigners, located in Lodz at 103 Piotrkowska St., at the window from 5-8 (ground floor) after prior booking of the visit, via website: rezerwacje.lodzkie.eu, in the following hours:

- Mon, Thu, Fri: 8.30-14.30, Tue: 10.00-17.00
- In the case of submitting documents to the registration office of the Foreigners' Department, an employee sets the date of the visit in order to make up formal deficiencies of the application and submit fingerprints.
- In the case of sending the application via the Polish post office, the deadline for supplementing the formal deficiencies of the application, including the submission of fingerprints, is indicated on the summons sent by post to the foreigner. When sending the application by post, send the application by registered mail and be sure to keep the proof of postage.



fees

The stamp duty depends on the purpose of the foreigner's stay in Poland. This is explained in detail in individual tabs on the website udsc.gov.pl/cudzoziemcy/obywatele-panstw-trzecich/chce-przedluzyc-swoj-pobyt-w-polsce/zezwolenie-na-pobyt-czasowy/podstawowe-informacje/.

Standard stamp duty:

- PLN 340 for a temporary residence permit:
- PLN 440 for a temporary residence and work permit.

Fee for issuing a residence card PLN 50.

A minor foreigner who, by the date of submitting the application for a temporary residence permit, has not reached the age of 16, is entitled to a discount in the fee for issuing a residence card in the amount of PLN 25.

basic documents

- completed application for temporary residence and its copy;
- · 4 biometric photos;
- a copy of a valid travel document (in most cases a foreign passport);
- confirmation of payment of stamp duty;
- Appendix N91 (in the case of a temporary residence and work permit):
- and other documents confirming the circumstances indicated in the application, depending on the basis of stay.



grounds for granting temporary residence permits

There are several reasons on the basis of which a temporary residence permit is issued:

- · performance of work;
- performance of work in a profession requiring high qualifications;
- performance of work by a foreigner delegated by a foreign employer to the territory of the Republic of Poland;
- · running a business activity;
- taking up or continuing full-time studies: first degree, second degree studies and uniform Master's degree studies, or education at a doctoral school:
- conducting research or development work;
- · long-term mobility of the researcher;
- completion of an internship;
- participation in the European Voluntary Service program:
- stay with a citizen of the Republic of Poland;
- stav with a foreigner:
- long-term mobility of a researcher's family member;

- · circumstances related to being a victim of human trafficking;
- circumstances requiring a short-term stay in the territory of the Republic of Poland;
- extension of stay on the territory of the Republic of Poland due to seasonal work.



residence status after submitting the application

If the application for a temporary residence permit was submitted during the foreigner's legal stay and the application did not contain formal defects or the formal defects were corrected on time, the voivode shall include a stamp in the foreigner's travel document, which confirms the submission of the application. A foreigner's stay is considered legal from the date of submitting the application to the date on which the decision on granting a temporary residence permit becomes final.



time of settling the matter

Due to the obligation to apply for information to the commander of the Border Guard Branch, Regional Police Commander, Head of the Internal Security Agency and, if necessary, also a consul or other authorities, whether the entry of a foreigner into the territory of the Republic of Poland and his or her stay in this territory may constitute a threat to defence or state security or protection of public safety and order, who are obliged to provide the above-mentioned information within 30 days of receiving the request, the decision on granting the permit will be issued only after 1 month from the date of initiation of the procedure. Currently, the waiting time may be up to several months due to the large number of submitted applications

permanent residence permit

A permanent residence permit is granted to a foreigner at his / her request, if he or she has a valid Pole's Card and intends to settle in the territory of the Republic of Poland permanently or has a confirmed Polish origin.

Legal basis: Act on foreigners of 12 December 2013 (Journal of Laws of 2017, no. 2206) together with implementing acts.



how to submit the application

The application is submitted by a foreigner applying for a permit in person to the voivode competent for the foreigner's place of residence, no later than on the last day of legal stay in the territory of the Republic of Poland.

When submitting the application, the foreigner is required to submit fingerprints. If the application is not submitted in person or is sent by post - after the application has been delivered to the voivode, the foreigner will be requested to appear in person within 7 days of the delivery of the summons, otherwise the application will not be examined



place of submitting documents

Documents should be submitted to the seat of the Department of Citizens' Affairs and Foreigners, located in Lodz at 103 Piotrkowska St., in room 33 (3rd floor), after booking a visit via the website www.rezerwacje.lodzkie.eu (tab: permanent stay for holders of the Pole's Card) in the following hours: Mon, Thu, Fri: 8.30-14.30, Tue: 10.00-17.00.

In the case of submitting documents at the registration office of the Foreigners' Department, the employee sets the date of the visit in order to fill in the formal defects in the application and submit fingerprints.

In the case of sending the application via the Polish post office, the deadline for supplementing the formal deficiencies in the application, including the submission of fingerprints, is indicated on the summons sent by post to the foreigner.



fees

The fee for granting a permanent residence permit is PLN 640. Holders of the Pole's Card are exempt from stamp duty for granting a permanent residence permit.

Fee for issuing a residence card PLN 50.

Time for settling the matter - The procedure for granting a permanent residence permit to a foreigner should be completed no later than within 3 months from the date of its initiation. The waiting time may be longer, e.g. due to missing documents confirming the circumstances indicated in the application.



- application form filled in as instructed and one photocopy of the completed application;
- 4 photos (undamaged, in colour, with good sharpness; dimensions 35 mm x 45 mm; taken not earlier than 6 months before the date of submitting the application).

Note: a foreigner wearing a hat in accordance with the rules of his/her religion may attach to the application a photograph showing him/her in a headgear, provided that the image of the face is fully visible. In such a case, the application shall be accompanied by the foreigner's declaration of affiliation to the religious community::

• a photocopy of a valid travel document (original available for inspection);

Note: The lack of any of the above-mentioned documents will result in the foreigner being summoned to complete it within 7 days from the delivery of the summons, under pain of leaving the application without consideration.



documents confirming the circumstances indicated in the application

Note: Attaching the documents listed below to the application when submitting it may reduce the amount of official correspondence and shorten the time of handling the case.

- a copy of a valid Pole's Card (original available for inspection);
- documents confirming the intention to stay in Poland permanently.

In the case of applying for a permanent residence permit, on the basis of Polish origin, it is also necessary to present supporting documents, translated into Polish by a sworn translator.



A right to a cash benefit supporting integration

A person who submits an application for a permanent residence permit on the basis of a Pole's Card may apply for a cash benefit!

- the application for granting a cash benefit is submitted to the voivode to whom the application for a permanent residence permit has been submitted;
- the application for granting the cash benefit is submitted within 3 months from the date of submitting the application for granting the permanent residence permit;
- cash benefit is granted for a period of up to 9 months;
- · cash benefit is determined in the amount of:
- in the first 3 months the equivalent of 50% of the minimum remuneration for work, applicable in the year of submitting the application for granting the cash benefit for the applicant and their spouse, and the equivalent of 50% of this amount for each minor child remaining under the parental authority of the applicant or their spouse;
- in the period from the 4th to the 9th month respectively 60% of the amounts specified above;
 - when determining the amount of the cash benefit, only family members of the applicant who stay with them in the territory of the Republic of Poland are taken into account.

buying an apartment

Are you planning to buy your first apartment in Poland?

Before you choose your dream apartment, read the practical guide we have prepared for you. We will try to briefly present the relevant information that you should pay attention to in order to make a safe and best decision for you.

Please read the short glossary first:

PCC3 tax - the tax on civil law transactions is 2% of the market value of the property and is paid at the notary's office when signing the notarial agreement.

The developer condition of the flat - there is no clear definition of the developer condition, because each developer can have their own, but usually the term developer standard is understood as: entrance door, plastered walls, floors made of concrete screed, plumbing and electrical installation, central heating installation with radiators, internal window sills, tiles on the balcony / terrace, finished balustrades.

What to look out for when buying a flat?

First of all, remember what the legal requirements are when buying real estate by a foreigner.

- A foreigner does not need to have any legal status to purchase an independent dwelling (or flat). This means that if you want to buy an apartment / garage in Poland, you must have one of the following documents: a visa, residence card, settlement permit or residence permit for EU long-term resident.
- However, to become the owner of a land property (e.g. a house, a plot of land) you need a permit from the Minister of the Interior. Such a permit will be granted on the basis of your application, if you confirm your ties with Poland and guarantee that your acquisition of the property will not endanger the defence, state security or public order. You can prove your ties with Poland if: you have Polish nationality or origin, you have a spouse who is a Polish citizen, you have a residence card or a residence permit for EU long-term resident, you are a member of the management board of a controlled commercial company or you conduct business or agricultural activity in Poland, in accordance with provisions of Polish law.

You will not need a permit to purchase land property if:

 at least 5 years have passed since the granting of a permanent residence permit or a residence permit for EU long-term resident;

- you are a spouse of a Polish citizen and you have lived in Poland for at least 2
 years since you were granted a permanent residence or a residence permit for EU
 long-term resident and you want to purchase real estate that will be part of the
 community property;
- you are a citizen of the Swiss Confederation or of the countries of the European Economic Area.

- When choosing an apartment, consider what features of the apartment will meet
 your and your family's needs. In addition to the layout and size, pay attention to the
 type of property and additional areas, such as a balcony / loggia / terrace, parking
 space in the underground garage or a storage unit.
- The housing market in Lodz is developing dynamically and, so that nothing surprises you in the future, do a small research and get to know the area where you are going to live. You can find out what will be built in the vicinity of your future apartment by checking the zoning plan, which is available to the public. All you need to do is go to the city hall and ask for such a document or look for information on the rsip.lodzkie.pl geoportal.
- Take into account the differences between primary and secondary market dwellings
 and the tax consequences thereof. When buying an apartment from the primary
 market, you have to take into account the distant date of receipt of the property and
 the expenses related to finishing, because most often it will be a property with a
 developer standard. On the other hand, apartments from the secondary market will
 not always meet your expectations, and sometimes they may require a major
 renovation.

Remember that:

- when buying a property from the secondary market, you will pay the PCC-3 tax.
 Unlike the secondary market, when you buy real estate from the primary market, you do not pay this tax;
- you can always use the services of a real estate agency and a credit advisor.
 What's more, you will not pay any commission for the advice of a real estate agent on the primary market and for consultations with a credit advisor. However, when buying a flat from the secondary market, you have to take into account the fee;
- When choosing a property on the primary market, you have the right to obtain an
 information prospectus from the developer, documents confirming that the
 developer is not in arrears with payments to the Tax Office and the Social Insurance
 Institution (ZUS), an excerpt from the National Court Register (KRS) and
 documents confirming the ownership of the land and a building permit. In turn, on
 the secondary market, check the owner of the apartment and read the notarial deed
 and the land and mortgage register before making a decision;
- before buying, check your creditworthiness if you intend to take out a loan and assess whether you have sufficient funds of your own - you will need your own contribution, an employment contract - preferably for an indefinite period, as well as a residence card:
- after buying an apartment, you have to fulfil several formalities: among others, submit an application to the court for entry in the land and mortgage register, pay tax on civil law transactions and submit a tax declaration to the City Hall.

looking for a job

Independent job search can be done via the Internet and the press, which greatly simplifies and speeds up finding a job, and at the same time helps to understand the possibilities of the local labour market, how we see ourselves on the local market and, above all, what kind of job would be right for us.

First steps of looking for a job on the Internet

To begin with, you need to prepare a CV. A recruiter spends several dozen seconds reading a CV, so make it concise, clear and contain the most important information (your data, education, work experience). If you attach a photo - keep it formal.

On the Internet you will find websites that will help you create a professional CV:

It is necessary to include your consent to use your personal data for recruitment purposes at the end of your CV! Send your CV in PDF format.

If you have a CV in Russian, it is possible for the office to translate it into Polish. The service is free: Zielonalinia.gov.pl/przetlumacz-cv-z-jez.-rosyjskiego

The office (an institution?) also helps to write and correct CVs - also for free. Zielonalinia.gov.pl/fabryka-cv-26886

On the portal you can view current job offers. Searching for job offers is very simple in this case, and based on your criteria, you gain access to the offers you are interested in.

Additionally, on the website you can find information on current events related to job search, job fairs and training courses.

An important step is to create an account and display your skills and professional experience to make it easier for future employers to reach you.

pracuj.pl

The website contains job offers, employers' profiles, and information on earnings in various industries. The portal offers the opportunity to create your CV and present yourself to future employers.

gratka.pl

The website is aimed at individual and business customers. In addition to sale and purchase announcements, it includes a category dedicated to job search.

linkedin.com

A professional website for building a network of contacts. It is a very good form of business communication. Each Linkedin member has their own account and should have their professional experience described. It is important that it is done as interestingly as possible, because there are many employers on the portal who look for their future employees there. By completing your profile and maintaining it regularly, you can gain a lot of contacts in the industry you are interested in. It is a place where people publish various articles, information about conferences, etc.

mlodziwlodzi.pl/praca-i-kariera- Youth in Lodz

The program of the city of Lodz is aimed at facilitating the process of searching for and obtaining a job by young people. The website contains news on the labour market and information about employers.

It is worth checking your future employer in the National Register of Offices of Economic Entities stat.gov.pl/regon or in the National Court Register krs-online.com.pl. These are places where you have basic information about the employer, his data and a brief description of the company.

You can also try to search for opinions about a potential employer on the Internet. On the gowork.pl portal, in the "opinions about employers" tab.

Another option of looking for a job is to use the help of an employment agency. It is worth checking the agencies - whether they are known on the market and respected. This will help to avoid wasting your time and ensure that you will not be taken advantage of.

- Search for agency reviews via the Internet, use social media profiles to search for as much information as possible.
- pay attention to agency workers do you feel that they are professional and qualified?
- with which companies does the agency work? Smaller, bigger, market leaders?
- check the agency in the Register of Employment Agencies (KRAZ) www.kraz.praca.gov.pl;
- information about the agency is also provided by employees of voivodeship labour offices (WUP), contact details of WUP are available on the website of the Portal of Public Employment Services: psz.praca.gov.pl/wybor-urzedu

Performing work in accordance with the law is very important both from the point of view of the foreigner and the entity entrusting him with the performance of work. A foreigner who performs work contrary to the provisions may be punished with a fine of not less than PLN 1000 and a decision obliging him to return to the country of origin. An entity entrusting a foreigner with illegal performance of work is exposed to misdemeanour or criminal liability.

A foreigner coming to Poland, e.g. for work purposes, should ensure that his stay is legal.

The employer's task is to obtain documents that will entitle the foreigner to work in Poland and allow him/ her to issue a visa or a temporary residence permit, so that they can perform their work.

The employer is also obliged to keep copies of documents confirming the legal stay of the foreigner in Poland.

Foreigners are entitled to work in Poland if they:

- reside legally and have a work permit, unless it is not required:
- have a temporary residence and work permit or a temporary residence permit in order to perform work in a profession requiring high qualifications.

Note: A foreigner may not work in Poland if they are staying on the basis of:

- a visa issued for the purpose of tourism, arrival for humanitarian reasons, due to state interest or international obligations;
- temporary residence permit granted pursuant to Art. 181 paragraph. 1 of the Act of 12 December 2013 on Foreigners, i.e. due to circumstances requiring a short-term stay of a foreigner on the territory of Poland.

obligation to obtain a work permit for a foreigner

A foreigner has the right to work in Poland if:

- resides legally in the territory of Poland and has a work permit or is exempt from the obligation to have a work permit;
- has a temporary residence and work permit or a temporary residence permit in order to perform work in a profession requiring high qualifications.

But there are **limitations**. A foreigner is not authorized to work if he/ she:

- stays on the basis of a tourist visa, for reasons of state interest or international agreements;
- is staying on the basis of a temporary residence permit due to circumstances requiring a short-term stay of a foreigner on the territory of Poland (Article 181 paragraph 1 (2013)).

But under what circumstances does a foreigner need a work permit and what is it? It is a decision which entitles a legally residing foreigner to perform work under the conditions specified in the permit. The document is issued by the voivode at the request of the entity entrusting the performance of work.

But a permit is not required when a foreigner:

- has the status of a family member of an EU / EEA / Swiss citizen;
- · enjoys international protection;
- has a permanent residence permit;
- holds a permit for a long-term resident of the European Union;
- has a residence permit for humanitarian reasons;
- has a tolerated stay permit;
- is a spouse of a Polish citizen with a temporary residence permit granted in connection with entering into marriage:
- has a temporary residence permit for the purpose of family reunification;
- has a valid Pole's Card;
- is a graduate of Polish upper secondary schools, full-time university studies or full-time doctoral studies at Polish universities;
- is a full-time student of studies in Poland or full-time participant of doctoral studies in Poland.

Statement

Citizens of Ukraine, Russia, Belarus, Georgia, Armenia and Moldova are an exception - their access to the labour market is facilitated. By means of a written contract and a written statement of the entity (confirming the performance of work registered in the relevant district labour office), they can perform work for a period of 6 months within the next 12 months.

In order to obtain a visa for the purpose of performing work, it is necessary to attach to the application a work permit or a written declaration of the employer about the intention to entrust work, if a permit is not required. Such documents can be obtained by the voivode at the employer's request. The permit specifies the employer, position or type of work, the lowest salary, working hours and the period of validity of the permit. There are also situations in which permits are not issued, for example, if the foreigner has been punished for certain crimes or entered in the register of undesirable foreigners in Poland or does not meet certain conditions.

Work permits vary and, depending on the type of procedure and criteria, the issuing process differs. A company applies for a work permit!

Type A - for people whose work is located in the Republic of Poland. A foreign worker must be paid not less than a local worker in a similar position. The permit is issued for a period of up to 3 years, but may be shorter in voivodship regulations.

Type B - can be obtained by a person who works on the management board of a company entered in the register of entrepreneurs. Issued for a period of up to 3 years, but if the enterprise employs more than 25 people, you can apply for a permit for 5 years.

Type C - can be applied for by a person working for a foreign employer who is posted to the territory of the Republic of Poland for a period of up to 30 days in a calendar year.

Type D - for a foreigner who will perform work for a foreign employer who does not have a branch or other form of organized activity in the Republic of Poland and is delegated for a temporary and occasional purpose.

Type E - for a foreigner who takes up work for a foreign employer, posted to the territory of the Republic of Poland for a period longer than 3 months within the next 6 months for a purpose other than the B, C, D permit.

Documents to be submitted when applying for a work permit:

- completed application for a work permit for a foreigner on the territory of the Republic of Poland;
- statement of no criminal record, signed by a natural person who is the entity entrusting the performance of work or acting as the body of an organizational unit which is the entity entrusting the performance of work.
- The indicated declaration may not be signed by the person who is the representative in the case;
- original of the information from the Starost (head of the district) referred to in Art. 88c paragraph 1 point 2 of the Act, issued not earlier than 180 days before the date of submitting the application, and in cases justified by the Starost 90 days before the date of submitting the application if it is required.

Photocopies of the documents listed below together with the originals for authentication i. e.:

- valid ID card or valid travel document or other valid identity document if the entity entrusting the performance of work by the foreigner is a natural person;
- a copy of all completed pages from the valid travel document of the foreigner to whom the application relates;
- articles of association if the entity entrusting the performance of work by a foreigner is a limited liability company in organization or a civil law partnership, or notarial deeds on establishing the company;
- a document drawn up by the user's employer, confirming the agreement on the referral of a foreigner by a temporary employment agency if the entity entrusting the work is this agency:
- proof of payment;
- documents confirming that the foreigner meets the requirements for job applicants by the entity entrusting the performance of work, as specified in the information from the Starost on the impossibility of satisfying the employer's staffing needs;
- documents confirming the fulfilment of the qualification requirements and other conditions in the event of the intention to entrust a foreigner with work in a regulated profession:
- a document from the relevant register confirming the legal status and form or nature of business conducted by the foreign employer - only in the case of an application for a type C, D or E permit;
- a copy of a declaration of the amount of income earned or loss suffered by the entity entrusting work to a foreigner as a taxpayer of corporate income tax in the tax year preceding the submission of the application - only in the case of an application for a type B permit;
- documents confirming the employment status for the year preceding the application
 only in the case of an application for a type B permit;
- documents confirming the circumstances referred to in Art. 88c paragraph. 4 point 2
 of the Act if the condition for issuing the permit is to prove these circumstances only in the case of an application for a type B permit;
- information about the current employment status in the entity entrusting the performance of work to a foreigner, if the party applies for a permit for a period exceeding 3 years only in the case of an application for a type B permit:
- an agreement under which the service on the territory of the Republic of Poland is or will be provided - only in the case of an application for a type D permit;
- documents confirming the occurrence of the circumstances referred to in Art. 88c paragraph. 8 of the Act;
- documents confirming the connections referred to in Art. 88 point 3 of the Act.

FEES:

PLN 50 - if the entity entrusting work to a foreigner intends to employ the foreigner for a period not exceeding 3 months;

PLN 100 - if the entity entrusting work to a foreigner intends to employ the foreigner for a period longer than 3 months;

PLN 200 - if the employer intends to delegate a foreigner to Poland in order to provide an export service.

In the case of submitting an application for the extension of the work permit of a foreigner, the entity entrusting the work to the foreigner shall make a payment in the amount of half of the above-mentioned amounts, respectively.

If a foreigner is staying legally and the purpose of the stay is to perform work, then he or she may apply for a temporary residence and work permit or a temporary residence permit in order to perform work in a profession requiring high qualifications. Permits are issued by the voivode.

A temporary residence and work permit is a type of a uniform permit for foreigners who intend to start or continue work in the Republic of Poland for a period longer than 3 months. The foreigner them self applies for a temporary residence and work permit!

How to submit an application:

The application is submitted by a foreigner applying for a permit in person to the voivode competent for the foreigner's place of stay, no later than on the last day of legal stay in the territory of the Republic of Poland.

When submitting the application, the foreigner is required to submit fingerprints.

If the application is not submitted in person or is sent by post - after delivery of the application to the voivode, the foreigner will be summoned to appear in person within 7 days of the delivery of the summons, otherwise the application will not be examined.

Place of submission of documents

Documents should be submitted to the seat of the Department of Citizens' Affairs and Foreigners, located in Lodz at 103 Piotrkowska St., at windows from 5-8 (ground floor) after booking the visit via the website rezerwacje.lodzkie.eu, in the hours: Mon, Thu, Fri: 8.30-14.30, Tue: 10.00-17.00.

In the case of submitting documents at the registration office of the Foreigners' Department, the employee sets the date of the visit in order to supplement the formal deficiencies in the application and submit fingerprints.

Time for settling the matter:

This document is not required if:

- the profession that the foreigner performs as part of the work entrusted to him or the type of work that is entrusted to him is included in the list referred to in art. 10 sec. 4 point 1 of the Act of April 20, 2004 on employment promotion and labour market institutions;
- the foreigner had a work permit or a residence and work permit for the same employer in the same position immediately before submitting the application;
- the foreigner meets the conditions specified in the regulations issued under Art. 90 sec. 5 of the Act of April 20, 2004 on employment promotion and labour market institutions:
- the foreigner meets the conditions for exemption from the obligation to have a work permit, specified in separate regulations;
- the work involves the performance of functions by a foreigner on the management board of a legal person subject to entry in the register of entrepreneurs, whose shares or stocks are not owned by the foreigner.

Note: Lack of any of the above-mentioned documents will result in the foreigner being summoned to complete it within at least 7 days from the delivery of the summons, under pain of leaving the application without examination.

Documents confirming the circumstances indicated in the application:

- in the case of fulfilling the conditions of exemption from the obligation to have a work permit a document confirming the fulfilment of these conditions (e.g. Pole's Card, Polish university diploma, Polish secondary school graduation certificate);
- if information from the Starost is attached documents confirming that the foreigner has the qualifications indicated by the employer in the information from the Starost;
- a document confirming the possession of a secured place of residence (e.g. registration certificate):
- employment certificate from the last employer (if the foreigner has previously performed work for another employer);

- PIT returns on the amount of the foreigner's income for the last tax year or a relevant certificate from the Social Insurance Institution, or other documents to certify a source of stable and regular income sufficient to cover the cost of living for oneself and dependent family members (for a single person PLN 701 net monthly, for a person in a family PLN 528 net per month):
- documents confirming health insurance (NFZ National Health Fund or private insurance);
- if the performance of work in the territory of the Republic of Poland consists in the performance by a foreigner of a function in the management board of a legal person subject to entry in the register of entrepreneurs, whose shares or stocks are not owned by the foreigner or acting as a proxy documents confirming that the entity entrusting the work meets the relevant conditions temporary residence permit for the purpose of conducting business activity;
- entry in the KRS (National Court Register) or CEIDG (Central Register and Information on Economic Activity) of the employer, in the case of a civil partnership civil partnership agreement.

A temporary residence permit for the purpose of performing work in a profession requiring high qualifications is issued to a foreigner who justifies a stay in the territory of the Republic of Poland for a period longer than 3 months and when the purpose of the foreigner's stay in the territory of the Republic of Poland is to perform work in a profession requiring high qualifications. The foreigner himself applies for a temporary residence permit for the purpose of performing work in a profession requiring high qualifications!

How to apply:

- the application is submitted by a foreigner applying for a permit in person to the voivode competent for the foreigner's place of stay, no later than on the last day of legal stay in the territory of the Republic of Poland;
- when submitting the application, the foreigner is required to submit fingerprints;
- you submit an application for a temporary residence permit in person, not later than on the last day of legal stay on the territory of the Republic of Poland;
- if the application is not submitted in person or is sent by post after delivery of the application to the voivode, the foreigner will be summoned to appear in person within at least 7 days from the delivery of the summons, under pain of leaving the application without examination the date with an indication of a specific date and time can be found in the letter sent by post office!
- if you submit the application on time and there are no formal deficiencies or you supplement the formal deficiencies within the indicated deadline, your stay will be legal from the date of submitting the application until the date on which the decision in this matter becomes final;
- if you apply for the suspension of the procedure for granting a temporary residence permit, your stay at that time will not be considered legal.

Note: Placing a stamp on the travel document does not entitle the foreigner to travel within the territory of other Schengen countries, while the foreigner may travel to the country of origin.

Documents confirming the circumstances indicated in the application:

- Information of a Starost competent for the main place of work by the foreigner about
 the inability to meet the employer's staffing needs, on the basis of the registers of
 the unemployed and job seekers or about the negative result of the recruitment
 organized for the employer, issued not earlier than 180 days before submitting the
 application, if it is required;
- in the case of meeting the conditions of exemption from the obligation to have a work permit a document confirming the fulfilment of these conditions (e.g. Pole's Card, diploma of graduation from a Polish university);
- a document confirming higher professional qualifications (a document certifying completion of higher education or confirmation of at least five years of professional experience at a level comparable to the level of qualifications obtained as a result of graduating from university):
- a document confirming compliance with the qualification requirements and other conditions in the event of the intention to work in a regulated profession:
- consent of the competent authority to occupy a specific position, practice a
 profession or conduct other activity, if the obligation to obtain it before concluding a
 contract results from separate provisions;
- · documents confirming health insurance;
- a document confirming that you have a guaranteed place of residence;
- home employment contract, civil law contract concluded for a period of at least 1 year.

A temporary residence permit may be granted to a foreigner on the basis of a seasonal work permit. The company applies for a seasonal work permit!

Seasonal work is work performed for a period not longer than 9 months in a calendar year in the following sectors: agriculture, horticulture, tourism, as part of activities recognized as seasonal, specified in the executive regulation of the Minister of Family, Labour and Social Policy on the subclasses of activity according to the PKD classification (Polish Classification of Activities), in which seasonal work permits of a foreigner are issued.

Such a permit may be granted to a foreigner who:

- came on the basis of a visa to perform seasonal work or under the visa-free regime;
- has a seasonal work permit or an extension of a seasonal work permit;
- has a source of stable and regular income;
- has health insurance;
- has secured a place of residence in Poland.

Procedure:

- the foreigner's seasonal work permit is issued at the request of the entity entrusting the work to the foreigner;
- the decision is issued by the Starost with jurisdiction over the seat or place of residence of the entity entrusting work performance;
- the employer submits an application for a seasonal work permit at the district labour office (PUP) competent for his seat or place of residence (the seat applies to a legal person, e.g. an enterprise, and the place of residence to a natural person);

- in the application, the employer specifies, among others, the proposed remuneration of the foreigner, working time or the number of working hours per week or month, the type of contract being the basis for the work and the period of validity of the permit. When submitting the application, the employer also attaches a proof of payment in the amount of PLN 30;
- if the permit concerns a citizen of a country other than listed in the regulation (i.e. other than Armenia, Belarus, Georgia, Moldova, Russia or Ukraine), the application should be accompanied by information on the result of the so-called labour market test:
- a seasonal work permit is issued if the amount of remuneration, which will be specified in the contract with a foreigner, is not lower than the remuneration of employees performing in the same period of time work of a comparable type or on a comparable position;
- a seasonal work permit is issued for a specific foreigner;
- during the validity period of the permit, it is possible to perform any seasonal work, not only the work indicated in the permit.

In a situation where the foreigner is already in Poland: the Starost verifies the application and issues a permit or refuses to issue a permit within 7 days or up to 30 days, if explanatory proceedings are required. If the verification was negative, the Starost refuses to issue a seasonal work permit.

In a situation where a foreigner will just apply to enter Poland for seasonal work:

- the Starost verifies the application and enters it into the register of applications for seasonal work or refuses to issue a seasonal work permit. Entry in the register takes place within 7 working days from the date of receipt of the declaration, unless an explanatory procedure is conducted then the entry takes place within 30 days. By entering the application into the register, the Starost shall issue to the entity entrusting the performance of work to a foreigner a certificate confirming that the application has been entered in the register of seasonal work applications;
- the entity entrusting the performance of work provides the foreigner with a certificate of entry of the application for a seasonal work permit to the register of applications for seasonal work. This certificate serves as the basis for issuing a visa for the purpose of performing seasonal work or, in the event that a foreigner enters without a visa, serves as a confirmation of the purpose of entry into the territory of the Republic of Poland;
- upon the foreigner's arrival, the employer informs the district labour office about this fact, presents a copy of the foreigner's passport and provides his/ her address of residence on the territory of the Republic of Poland. After fulfilling the abovementioned obligation, the Starost issues a seasonal work permit;
- a foreigner may work while waiting for a seasonal work permit, i.e. after the entity has informed the office about the foreigner's arrival.

A work permit in Poland entitles one to work only on the territory of the Republic of Poland.

employment of a foreigner

When employing a foreigner, the employer is obliged to:

- check whether they have a valid residence permit;
- make copies of the residence permit and keep it during the period of work of the foreigner;
- enter into a written contract under the terms of a work permit;
- present the contract to the foreigner before signing, in a language he / she understands:
- provide one copy of the work permit in writing to the foreigner;
- inform about activities aimed at granting or renewing the permit and decisions on the permit;
- notify the voivode within 7 days if the foreigner does not start work within 3 months or breaks it for a period longer than 3 months or ends it earlier than 3 months before the expiry of the work permit.

When employing a foreigner on the basis of a work permit, the employer has the same obligations as towards a Polish citizen:

- report within 7 days from the date of commencement of work to the social and health insurance and to pay monthly contributions to the Social Insurance Institution in the appropriate amount (not applicable to a specific task contract);
- calculate, collect and pay advances for income tax;
- comply with the provisions of the Labour Code.
 You can legally employ a foreigner who is not a citizen of EU Member States, EEA or Switzerland, provided that the following conditions are met:
- obtaining a work permit or an issued declaration on entrusting work, which will be entered in the register of statements of the district labour office, or obtaining a temporary residence and work permit by the foreigner them self;
- the foreigner legally resides on the territory of the Republic of Poland;
- the basis for residence allows you to work.

Citizens of EU / EEA Member States and Switzerland are exempt from the obligation to have a work permit, visa or temporary residence permit in Poland.

The employer may entrust work to a foreigner without the need to obtain a work permit, if he has in the Republic of Poland:

- refugee status;
- subsidiary protection;
- · permanent residence permit;
- long-term resident's permit for a resident of European Union;
- permission to stay for humanitarian reasons;
- consent for tolerated stay or benefits from temporary protection in Poland;
- applies for international protection and has a valid certificate issued by the Head of the Office for Foreigners.

Foreigners are also exempt from the obligation to have a work permit in other situations:

- have a valid Pole's Card;
- are spouses of a Polish citizen (they have a temporary residence permit in connection with getting married);
- are students of full-time studies in the Republic of Poland or participants of full-time doctoral studies in Poland;
- are graduates of Polish post-gymnasium schools, full-time higher education studies or full-time doctoral studies at Polish universities, research institutes of the Polish Academy of Sciences or research institutes;
- are teachers of foreign languages;
- they are sportsmen (they perform work up to 30 days in a calendar year for an entity based in Poland).

If a foreigner is a citizen of Ukraine, Belarus, Russia, Moldova, Georgia or Armenia, instead of a permit, he or she may receive a declaration on entrusting work to a foreigner, if the work will be performed for no longer than 6 months in the next 12 months. To obtain it, it must meet certain conditions:

- submit to the district labour office a written declaration of entrusting work to a foreigner;
- have the declaration entered by the labour office in the register of declarations;
- the work must be performed under the conditions specified in the declaration;
- the job is not regarded as seasonal work.

In seasonal work, from 2018 onwards, it is possible to obtain a permit for all third-country nationals. The purpose of obtaining the permit includes various types of farming, animal husbandry and breeding activities, as well as accommodation and catering services. A seasonal work permit is issued for a specified period of time, which cannot be longer than 9 months in a calendar year.

A foreigner who intends to stay in Poland and work in Poland for more than 3 months may obtain a temporary residence and work permit. Such a permit entitles the foreigner to stay and work. The foreigner them self applies for such a permit. To obtain such a permit, a foreigner must have health insurance, a source of stable and regular income. At the same time, the foreigner must have a place of residence in the territory of the Republic of Poland. In the event of a job loss, a foreigner must notify the voivode who granted the permit in writing within 15 working days. The voivode may also withdraw the permit in the event of a change of position or reduction of remuneration, if the permit has not been changed.

A temporary residence and work permit may not be withdrawn if the foreigner has lost their job, but:

- notified the voivode of this in writing or the notification was not received by the voivode for reasons beyond the foreigner's control;
- the period of unemployment did not exceed 30 days;
- such period occurs not more than once during the validity of the permit. Please note that a foreigner may look for a new employer within 30 days.

Remember that employees do not independently deal with formal issues related to health, social or other insurance - the employer must register employees for insurance, and then settle and pay contributions!

types of contracts on the basis of which work can be started

The employer may employ a foreigner both on the basis of an employment contract and a civil law contract

The employment contract indicates such elements:

- identification of the employer and employee;
- indication of the type of contract and the date of its conclusion;
- · type of work;
- remuneration corresponding to the type of work;
- · date of commencement of work;
- working time, i.e. the size of the job.

The most common employment contracts are:

- fixed-term contracts
- · contracts for an indefinite period.
- A fixed-term contract is concluded for a predetermined period of time specified by the employer and the employee, which means that it is a contract that is valid for a specified period of time.
- An employment contract for an indefinite period may be terminated by agreement of the parties on a date agreed by the parties. If the employee or the employer wants to terminate this type of contract, they must notify the other party in writing. The employer is also required to state the reason for the termination of the contract.

Civil law contracts are most often used when the employer does not plan to hire an employee on the basis of an employment contract, but wants them to perform specific activities or perform clearly defined tasks.

The most popular civil law contracts are:


- contract of mandate:
- contract for specific work.
- A contract of mandate consists of ordering a specific work to be performed by the employee within a specified period of time and payment of the agreed remuneration for this work. Within its framework, the contractor undertakes to perform certain activities for the principal. A contract of mandate is therefore a due diligence contract. The parties to the contract include in the contract the type of activities, their scope, organizational framework and remuneration the amount included in the contract is the gross amount.
- A specific work contract is a contract for the performance of a "work", that is, a clearly defined task that produces a specific product. Thus, a specific work contract is a contract of the result. The work (product) must be clearly defined and be at least partially material.



A foreigner is insured in the country where he or she will work. Compulsory health insurance applies to employees and persons with an agency, mandate or other contract to which the provisions of the contract apply.

Nationals of foreign countries whose residence is not permanent and who are employed in: foreign diplomatic representations, consular posts, missions, special missions, international institutions, are not compulsorily insured unless international agreements state otherwise.

Determining which type of insurance a foreigner is subject to depends on the employment contract and the possession of other titles to cover social insurance. In the case of an employment contract, retirement, disability, sickness, accident and health insurance is compulsory. In the case of a contract of mandate, health insurance is voluntary, if social contributions are mandatory. The employer is also obliged to pay contributions to the Labour Fund and the Guaranteed Employee Benefits Fund for the employee.



labour law PIP



■ PIP (National Labour Inspectorate) is a state institution that controls the implementation of labour law provisions concerning, for example, occupational safety or health. If an employee has any doubts as to the employer's compliance with the law, he or she may apply to PIP for advice in the field of labour law. As a result of a complaint, an inspector may intervene and take legal measures.

PIP's tasks include:

- control of compliance with labour law;
- compliance with the provisions on the employment relationship, remuneration, working time, etc.;
- control of employment of young people and people with disabilities;
- control of the legality of employment;
- prevention and reduction of hazards in the work environment;
- control of employee records;
- prosecuting offenses against employee rights;
- control of compliance with the obligation to conclude PPK (Employee Capital Plans) management contracts and PPK management contracts;
- monitoring compliance with the provisions of the Trade Act;
- the right to bring legal actions.



ESTABLISHING A COMPANY IN POLAND

If you want to start your own business, you must first consider a few things, such as: type of company, funding, business plan, information on the details of running your own business.

Before you decide to start your own business, consider:

- * in which field you want to work, what will the business preparation and development plan look like, whether it will pay off;
 - * ask experienced entrepreneurs about the specifics of running a business;
 - * choose the form of activity (business or company);
 - * find capital.

Economic activity, according to the Journal of Laws 2004 No. 173 item 1807 is a gainful production, construction, trade, service activity, as well as the search, identification and extraction of minerals from deposits, as well as professional activity carried out in a continuous and organized manner.

The group of migrants who have the opportunity to run a business include:

- persons with a permanent residence permit;
- residence permit for EU long-term resident;
- for a temporary stay for the purpose of family reunification;
- for temporary residence on the basis of a residence permit for EU long-term resident;
- temporary stay of a family member of a foreigner who has a residence permit for EU long-term resident;
- temporary stay in order to undertake or continue full-time university studies or full-time doctoral studies in Poland:
- temporary stay and they are married to a Polish citizen living in Poland;
- people with refugee status;
- persons with subsidiary protection;
- persons with a tolerated stay permit;
- people who benefit from temporary protection in Poland;
- people with a Pole's Card.

Foreigners, other than the above-mentioned persons, may undertake and conduct economic activity only in the form of a company.

A sole proprietorship is a simple type of business and can be set up by an individual. Such activity does not require a minimum capital, and the entrepreneur is responsible for the liabilities resulting from running the activity with all his assets.

Accounting depends on taxation: if it is on general principles, then accounting is simplified, with a lump sum a lump sum register is necessary, and with a tax card there is no accounting obligation.

The entrepreneur has the exclusive right to represent the business and the company name must include the applicant's first and last name.

To start a business, you must obtain an entry in the register of entrepreneurs in the Central Register and Information on Economic Activity. When registering on-line, you must have an electronic signature – for how to obtain it, see part 1 of the guide for foreigners in Lodz, entitled "First steps" in chapter 4 "e-PUAP" on page 16. The waiting time for business registration can be extended up to 30 days, if you do not immediately submit the relevant documents confirming your residence status, which entitles you to start a business - these are scans of your decisions, residence cards and passports.

limited liability company

A limited liability company is the most popular form of company in Poland. It is a suitable form of activity, e.g. for partners who want to maintain direct supervision over the company's affairs and limit the risk only to their contribution (no liability with personal property).

If you are not authorized to establish a business, you can set up a limited liability company. Limited liability companies have legal personality, which may be created by one or more partners. Its founders may be natural or legal persons, regardless of their citizenship and place of residence. The minimum share capital is PLN 5,000. When establishing a company, you must attach a statement that the company is a foreigner and provide addresses for service of partners and representation.

In the case of a company, full accounting is required - i.e. a foreigner must use the services of an accounting office.

Establishing a company does not take much time, everything can be done using the S24 platform. In order to set up a company on-line, each of the partners must have a trusted profile (see the first part of the guide for foreigners in Lodz entitled "First steps" in chapter 4 "e-PUAP" on page 16 for how to obtain it), by which documents and applications are signed. The stamp duty at the registration of the company is PLN 351 and is payable upon sending a set of documents, completed and signed, to the court.



Each entrepreneur must pay and settle taxes when running a business. However, with a limited liability company a CIT declaration is submitted.

PIT is a direct personal income tax, and the subject of taxation is a natural person who obtains income. PIT is collected both from Polish residents and from people who do not have Polish tax residence.

To settle PIT, you need to prepare and submit an annual tax declaration. Such a declaration is a condition for the payment of tax or a refund of overpayment.

To effectively settle PIT pay attention to:

- · correctness of the form;
- indication of revenue, expenses, income, amount etc.;
- · signature:
- if you are settling for the first time, it is worth consulting an accountant.

On the website podatki.gov.pl you can find information about the types of taxes, their specificity, as well as the rights and obligations of taxpayers.

bookkeeping

When running your own business, you need to consider accounting. Simplified accounting can be used by one-person business activity. This is possible when the operating income for the previous year is not more than EUR 2,000,000. Simplified accounting does not require keeping full books of accounts and comes in three variants: Revenue and Expense Ledger, Recorded Lump-sum and Tax Card.

The revenue and expense ledger is based on keeping a document that records all corporate revenues and expenses on the basis of which the tax amount is calculated. Enterprises using the revenue and expense ledger do not pay tax for those accounting periods in which they do not generate a profit.

- A lump sum on registered revenues consists in the fact that the taxpayer pays a fixed tax rate, the amount of which depends solely on the type of activity performed.
- The Tax Card is based on paying a fixed amount of tax liability, regardless of the amount of income obtained. The amount of tax depends on the type of business, the number of people employed and the number of residents living in the town where the business is conducted.
- Full accounting is provided for limited liability companies and for entrepreneurs who have exceeded net revenues from the sale of goods, products and financial operations of EUR 2 million converted into PLN at the average exchange rate announced by the National Bank of Poland on the first business day of October of the previous year.

Full accounting allows you to record revenues and expenses, calculate the amount of tax liabilities, and obtain a complete picture of the company's financial situation. As part of full accounting, the following documents apply: general ledger, subsidiary ledgers, list of assets and liabilities, or a statement of turnover and balances.

social security

Social insurance includes retirement, disability, accident and sickness insurance. Compulsory retirement, disability and accident insurance, but exempt from sickness insurance, applies to an employee:

A person is subject to compulsory pension, disability and accident insurance, but not sickness insurance:

- if they perform an agency contract, contract of mandate or a contract for the provision of services or cooperate in the performance of these contracts;
- if they conduct non-agricultural activity or cooperate in carrying it out;
- if they are a clergyman.

A person is subject to compulsory pension and disability insurance, but not sickness and accident insurance:

- if he or she receives a maternity benefit or an allowance in the amount of maternity benefit or is on parental leave and is not entitled to a pension or disability pension or other titles to compulsory social insurance;
- if he or she receives a carer's benefit, a special carer's benefit or a benefit for a quardian;
- is a member of the supervisory board and receives remuneration for performing this function.

When operating in Poland, you can only have social insurance in one country at a time. This must be the country of residence or the country where the centre of your business interests is located. In order to determine in which country a significant part of the activity is carried out, attention must be paid to turnover, working time, number of services or income. The document that states where contributions should be paid is the A1 Certificate. If you conduct business in accordance with the rules applicable to Polish entrepreneurs, you can arrange insurance at ZUS.



culture for foreigners

Lodz is described as a city of four cultures. In the nineteenth century, there was a huge development of Lodz related to the textile industry. New residents were coming to Lodz looking for work. In 1815, less than 1,000 people lived in Lodz, in 1915 it was as many as 600,000 inhabitants (600 times more!). Not only Poles came to Lodz, but also immigrants from various parts of Europe. The new inhabitants brought various religions and customs with them. Apart from Poles, the most important part of society were Jews who came to Lodz not only from other Polish cities, but also from abroad. The Jews were a wealthy group that dealt with trade and crafts. They also owned factories and banks.. Qualified professionals, mainly from Germany, were brought to Lodz. Among the new residents, there were also Russians occupying clerical positions.

Currently, nearly 1/5 of the inhabitants of Lodz are foreigners, mostly from behind the eastern border. The city undertakes various actions to help them integrate and get to know Lodz.



Festival of 4 Cultures

The Lodz of Four Cultures Festival has been organized since 2010 and is a continuation of the Festival of Dialogue of Four Cultures created by Witold Knychalski in 2002. It is an event that combines elements of music, theatre, literature, film and visual arts. It is aimed at a very wide audience of all ages. The name of the festival refers to four cultures that have influenced the history of Lodz: German, Jewish, Polish and Russian. The idea was born out of the historical dialogue of cultures that had been going on in Lodz for many decades. But now it is expanding its idea to other fields and cultures that are present in the city. On the one hand, the festival aims to show the potential of the artistic community in Lodz, and on the other, by inviting guests from Poland and abroad, it aims to co-create new cultural events of not only local, but national and international importance.

NGO - what is it? Can I set up an NGO?

NGO is a non-governmental organization whose activities are not focused on making a profit. A characteristic feature of non-governmental organizations is the lack of connections with public authorities. NGOs are primarily foundations and associations.

Running areas

- Józef Piłsudski Park. The advantage of this place is the varied terrain, which means you can run along the lit and paved park alleys, but also along the cross-country tracks. In the southern part of the park you will find a freely accessible polyurethane athletics track over 2 km long with a cushioned surface and distance markings every 200 meters. It's the perfect place for speed training.
- Poniatowski Park. This place is known to most runners in Lodz, and this is due to, among others, the Park run at a distance of 5 km, which takes place every Saturday. The Prince Józef Poniatowski Park, located in the central part of the city, is a place for running mainly on a flat surface. But during the Decathlon Run held here, the route of which leads through a highly varied terrain, you can find out that it is also a perfect place to work on running strength.
- May 3 Park. It is a park complex with varied and illuminated paths allowing you to run all year round. You will find, among others, a hill, perfect for practicing ascents.
 For several years now, the Grand Prix Lodz City Trail series has been held here. The park was also an arena of struggles during the Academic Polish and World Championships in cross-country running.
- Widzewska Górka Park there is a multifunctional sports complex of the same name, with a four-track athletic track, an outdoor gym and an exercise area. It's also a great place to do high-speed training and stretching.
- Adam Mickiewicz Park (formerly Julianowski Park). There are mainly asphalt alleys here. The park is partially lit. You can find a lot of runners in it, and in the recreational part you will find hills that will help you build running strength.
- Łagiewnicki Forest. Mecca of Lodz runners, a great place for ultra-running training. You will find here hundreds of paths, long ascents and descents. It is the largest recreational area in Lodz and one of the largest forest complexes located within the city limits in Europe. Especially for runners, there is a well-marked 5.5 km cross-country loop (www.lodzkietrasybiegowe.pl/lagiewniki), and long-distance runners can run around the forest (approx. 20 km) along a marked trail. During the year, many running events take place here, including: New Year's Eve Run, Szakal Half Marathon, DOZ Cup, Lodz Mountain Runs.
- Stoki Gen. Mariusz Zaruski Park is the most "mountain" park in Lodz, and next to it there is a public stadium with a 400-meter tartan track. Therefore, this combination gives one of the most interesting running places, especially for runners who want to improve their speed.
- Lublinek areas around the airport and Lublinek Forest, the second largest forest complex in Lodz. These are places with a varied terrain, very popular among runners living in the Retkinia estate and its vicinity.
- Ruda Popioty Street and the hills in its vicinity on Ruda Pabianicka are places that have been used by Lodz runners for years. Edyta Lewandowska, Joanna Chmiel, RKS Lodz competitors and hundreds of other runners preparing for the Lodz Marathon trained here. Also, after training on Popioty, the runs on the cross-country tracks will not be scary for anyone. Nearby, you will also find the RKS Lodz athletics hall, where, among others, Adam Kszczot trains.

There are over a dozen generally accessible brine graduation towers in Łódź. Some of them are located in housing estates, others are available in parks. The main material of the Lodz graduation towers are blackthorn twigs. This is where the brine flows down, breaking into smaller drops. Thanks to the sun's rays and gusts of wind, a brine mist is created, which is blown around the graduation tower, creating a microclimate that is beneficial to health.



RELIGIOUS UNIONS - MULTI-RELIGION LODZ

Lodz is described as the city of four cultures and religions. In 1815, less than 1,000 people lived in Lodz, in 1915 it was as many as 600,000 people (600 times more!). Immigrants from various parts of Europe came to Lodz: Jews (who came to Lodz not only from other Polish cities, but also from abroad), Germans (most were Protestants), Russians (most were Orthodox).

In total, at the end of the 19th century Lodz was inhabited almost in half by Catholics, every third inhabitant of Lodz was a follower of religion of Moses, almost 1/5 were Evangelicals and about 2% were Orthodox.

In total, there are several dozen churches and religious associations in Lodz.

Lodz is the seat of the Lodz metropolis, one of the 14 metropolises of the Latin rite in the Polish Catholic Church. It includes the Archdiocese of Lodz and Łowicz. archidiecezja.lodz.pl

religion in schools

Education in religion and ethics is organized in schools at the request of parents or adult students.

As of 1 September 2014, the principle of expressing this request in the form of a written declaration has been in force. Religion and ethics are not compulsory subjects for the student, participation in them is voluntary. So the child can:

- · participate in religion classes;
- · participate in ethics classes;
- participate in religion and ethics classes;
- · choose neither ethics nor religion.

You can resign from participation in these subjects at any time, also during the school year.

The kindergarten and school are obliged to organize religion lessons for a group of not less than seven students of a given class or kindergarten group. For a smaller number of students in a class or kindergarten group, religion lessons should be organized in a group consisting of children attending from different classes or groups.

If in a kindergarten or a school less than seven students (pupils) apply for classes of a religion of a given denomination or denominations jointly teaching, the governing body of the kindergarten or school, in consultation with the relevant church or religious association, organizes religion classes in an interschool or out-of-school group (outside kindergarten) catechetical point.
